Topic 1 - Enhancing Construction Productivity

The e-quick-BQ is a software program that can produce quick Bills of Quantities (BQs) based on Building Information Models (BIMs) and Construction Electronic Measurement Standard (CEMS).

Topic 3 - 12 Attributes of a Sustainable Built Environment

Synopsis

This policy paper outlines twelve principles of sustainability that are applicable to the design, construction, operation and disassembly of the built environment across its varying scales, from standalone buildings to neighbourhoods and cities. The twelve principles are drawn from numerous expert opinions; they describe, in effect, a global consensus on how the built environment should behave in a world of limited resources.
